Due to several different interpretations and treatments found in regards to granting Visit Visa and Visa on Arrival Exemption for Foreigner Identified as British Citizens with Travel Document, here with respect to Head of Regional Office we request them for assistance to order the Head of Immigration Office who authorized Immigration Checkpoint (TPI) to deliver the following notice:

1. Based on Presidential Regulation No. 21 of 2016 concerning Visit Visa Exemption and Regulation of Minister of Law and Human Rights No. 39 of 2015 concerning the ninth amendment of Decree of Minister of Law and Human Rights No. M.HH-01.GR.01.06 of 2010 concerning Visit Visa on Arrival, it states that England is included as a subject in the Regulation mentioned above;
2. Based on the official announcement released by British Government through their website, <https://www.gov.uk/types-of-british-nationality>, it states that only British Citizens with British Passport (United Kingdom Passport) that is acknowledged as British Citizen and is granted full rights as state citizens.
3. Foreigners identified as British Citizens who hold travel documents as the following:
 - a. British Overseas Territories Citizen;
 - b. British National (Overseas);
 - c. British Overseas Citizens;
 - d. British Subject; and
 - e. British Protected Person.

is obliged to have Visa in order to enter the territory of Indonesia.
